### FOSC/ARK Fall Litter Hotspot Cleanups

This fall, FOSC will continue to tackle litter hotspots with 3 partners - Anacostia Riverkeeper (ARK), One Montgomery Green (OMG), and Neighbors of the Northwest Branch (NNWB) - throughout in the Montgomery County part of the Anacostia River watershed.

Through this initiative we'll reduce litter and create detailed pollution-specific data to help educate Montgomery County residents and leaders about the litter problem, its movement via stormwater through our waterways, and what can be done to reduce its impact on local communities in the Anacostia Watershed.

### Sweep the Creek - Sat. Sept. 28 & Sun. Sept. 29 in Sligo Creek, Long Branch and Wheaton Branch

Since 1994, on the fourth Saturday of September, the nation's largest single-day volunteer effort has been held - National Public Lands Day. Friends of Sligo Creek will celebrate the day with **Sweep the Creek litter cleanups on Sat. and Sun., Sept. 28 & 29** throughout the watershed.

Check the <u>Sweep the Creek page</u> of the FOSC website in mid-September for the Sweep locations and schedule. FOSC volunteers will distribute bags and gloves for participants at each Sweep location. We will send the schedule to FOSC members by email as well. Weed Warrior events may also be held too. Stay tuned.

Continuing our #1 streak from 2023, FOSC volunteers have removed more litter this year than any other watershed group in MoCo.

Let's get out there to preserve and protect the ecological health of our watershed!

### Tree Appreciation Tour & Native Tree Planting - Sat Oct. 5 10:00am - 12:00pm

Led by FOSC master naturalists Bruce Sidwell and Ross Campbell. With the FOSC checklist of common local native woody plants in hand, participants will tour around the meadow and nearby with Bruce and Ross to talk about the 20 native woody species growing there. The trees will be temporarily labeled for a time, perhaps through mid-October. We're also working on getting two native trees to plant as well.

Come out to learn about our native trees and lend a hand planting. No registration needed. (Weed warriors can get work credit for assisting with the planting.)

Meet at Sligo Creek Parkway at Dallas Ave, across the footbridge just beyond the kiosk at the playground and small meadow. Look for the FOSC table.

### Litter Hotspot Cleanups

It takes a lot of effort to keep the Sligo watershed clear of litter. We thought we'd show you a few snapshots of volunteers in action at this summer's hotspot cleanups.

Thanks to everyone who came out to the cleanups , and to our ploggers, Adopt-A-Road volunteers, and Weed Warriors who collect many more bags of trash all along the watershed.

#### June 29 at Green Meadows Park in Hyattsville, lower Sligo

FOSC's newest Section 1 Stewards Jesse Johnson and Fatima Yousofi led the first-ever FOSC cleanup at Green Meadows Park in Hyattsville, close to the confluence of Sligo Creek and Northwest Branch. Litter masters Ed Murtagh and Nick Clements lent their experienced hands on what was a very warm and truly muggy Saturday!

The volunteers and leaders worked tirelessly for two hours cleaning up in the woods and along Sligo. When all was said and done we had removed the predictable dozens of the beer bottles, cans, and plastic beverage containers, and lots of trash - ten 50 gallon trash bags, two mattresses, plastic netting (particularly hazardous to birds and small mammals) and tarps.

#### July 20 at Kemp Mill Stormwater Ponds in Upper Sligo

FOSC and One Montgomery Green co-hosted the July Hotspot Cleanup & Stewardship Day at Kemp Mill stormwater ponds in Section 9 near the Sligo Creek headwaters.

We had a great day thanks to our Litter Hotspot Coordinator Nick Clements, our Sligo Weed Warriors, and over 50 volunteers who collected 25 bags of trash. The weed warriors freed many trees from vines and removed many non-native invasive plants. Thank you everyone!

### Whizzing Along the Trail

You may have noticed during your walks through the park this summer that the paths can become filled with lots of highly diverse traffic – walkers, joggers, kids in strollers, kids on tricycles, walkers with dogs, motorized scooters, motorized bikes, racing and fat-tire bikes, rollerbladers, and even the odd unicycle.

As the **MontgomeryParks.org** website notes, the Sligo trail "is the heaviest-used facility in the stream valley park and provides recreation for persons of all ages and abilities."

You may have also noticed that in many places the path is not wide enough to accommodate all that traffic.

Of greatest concern to those on foot are fast-moving bikes that come too close, at too high speeds. Bike riders need to recognize that some of those on foot may be hard of hearing, or busy concentrating on helping a child, or keeping their dog away from a hazard, or listening to a podcast or talking on the phone.

In other words, a little caution and forethought by bicyclists would do a great deal to ensure that all who wish to enjoy the park can do so safely. Bike bells and calling out your presence in advance is a courteous and thoughtful approach, as is leaving the path so you are well away from pedestrians and dogs.



So many of us love Sligo Creek Park and value the way it enhances our lives. How we treat others when we use the Park can go a long way toward making sure we all feel, and are, comfortable and safe on the trails.

### **BioMonitoring in Sligo**

From an upper Sligo neighbor:

A biomonitoring crew from MoCo Parks was spotted on Tuesday at the Ladd Street bridge at the foot of Nicholas Drive in upper Sligo (Section 9). They had just completed a survey of creek life.

Matt Harper, head of the Resource Analysis unit, explains:

"The sites we monitor from year to year are chosen based on a 5-year rotation of all the Parksmanaged stream valleys in the county, pre and post-environmental restoration monitoring, targeted pollution/environmental impact investigations, Planning Department initiatives, and to track health within our designated Best Natural and Biodiversity Areas. The site [at Ladd St. bridge] we were monitoring on Tuesday was targeted to evaluate the potential for future restoration opportunities."

Electrofishing uses a mild electrical current (see the backpacks, above photo) to temporarily stun fish, tadpoles, and other life forms, allowing the crew to net and record the species, their numbers, life stage and health, then safely release them. Certain species are more sensitive to pollution while others are more tolerant; the presence or absence of these species give an indication of stream health. (See <u>Parks' website</u>.)

Data collected from aquatic insect and fish sampling and other parameters are analyzed to generate an Index of Biotic Integrity (IBI) score and a rating of Excellent, Good, Fair or Poor.


In Sligo, the 5-year rotation site for annual August biomonitoring is in mid-Sligo just downstream of the Carroll Ave. bridge. Unfortunately, Sligo continues to receive a "Poor" rating.

This year Parks is also monitoring two sites in Long Branch as part of a baseline study ahead of the Purple Line fish passage restoration project at Piney Branch.

As readers may know, FOSC is a part of a macroinvertebrate testing team, along with UMD, Nature Forward, and other volunteers, that monitors macroinvertebrates 3x/year, most recently on July 21 in lower Sligo.

The results show a continued "Poor" rating based on the low numbers and low diversity of bug species, with pollution-tolerant species predominating. Examples of insect macroinvertebrate larvae


